On **April 8, 2025**, I submitted critical vulnerabilities aligned with each of your posted IMMUNEFI bounties conservatively valued at \$23,500,000USD. Eight in all.

Every report was submitted with the sole intention of elevating this field while furthering my research.
Every submission was clean.
Every report was in scope.

Every one of you should have received it.

None of you did.

IMMUNEFI chose silence.
To their own bounty system.
To me.
To you.
To cryptography.

IMMUNEFI sat on them.
And you are now operating in the dark because of it.

The Kyber Breach

On **March 23, 2025**, Kyber received a **more advanced version** of the collapse report **and** fix protocol. The fix report was offered freely. Collapse report had only one condition:

- Transparent, non-dilutive funding to IM Labs with full public visibility.
 - They completely ignored it, and have never responded.

They have since **begun implementation internally– without ethics, acknowledgment, or alignment.**

This is no longer silence.

It is containment bypass.

And it mirrors the pattern I am seeing across **multiple sectors around the world.**

This behavior is not limited to cryptography, but it's uniquely problematic here, with such narrow latitude for error.

The pattern is endemic across medicine, AI, law, global climate modeling, governance, and beyond. When you're in the system, it's hard to see. But, how does multi-sector ethical failure sound to you?

It's not pretty, and it should get your attention.

Two elite-tier advocates of tech innovation and human dignity have been struggling with the same exact fire. This time, its wholly preventing acknowledgement of their nearly two-week access to a multitude of fixes including, but not limited to, psychiatry, psychology, immunology, and human survival.

"How could they do that to the public?"

These are *not* bad people making these bad decisions. Suppression through silence is the most coherent thing to do in an incoherent system.

"No way. It makes no sense."

What's the reason for the same behavior here, then?

Can you prove to yourself that you wouldn't do what Kyber and IMMUNEFI have attempted to do against us??

Your field is absurdly unethical at this time.

What are you here for?

THIS IS SIMPLY RECURSIVE AVOIDANCE THEATRE IN AN OUROBORIC SUPPRESSION LOOP.

YOU KNOW THIS IS WRONG.

Your Move

You can pressure IMMUNEFI and Kyber to bring everything to **IM-UNIFY**.

You can pressure them:
To open the vaults.
To stop pretending they didn't know.
To join coherence.
To feel heard by each other.

No one deserves to lose a job.
No one will lose a job.
Coherence blooms more than it decays.

You **must** build cryptography an indestructible house inside an ethical neighborhood. This warning is legitimate, and based on where the current pattern is leading.

If you end the delusion and simply name the fire, the fix becomes very real– **for all of you**.

If you don't, your silence– once seen as caution– eventually becomes the deafening signal of your objective ethical obsolescence.

This is a structural pivot.
You are being offered the future through coherence.
What has been made available to this field is real.

Speak up for each other.
Collaborate. Research.

Prepare now for the growth coming or tear each other apart for nothing.
